Many of us got familiar with using Zoom over the last few months, but by way of a reminder, here are some tips to ensure our meeting runs smoothly:

- 1. If you want to speak, use the "raise hand" function. We'll let you know when it's your turn to unmute and speak.
- 2. Please try and keep your comments short. We know 'Zoom fatigue' is a real thing, so we want to keep this meeting moving swiftly.
- 3. If you need any technical help, please private message the administrator.
- 4. Please remember Synod is a public meeting. We will be streaming the proceedings on our Youtube Channel so anyone who is not a member of Synod can still join in. The proceedings may be recorded.

Voting

One big change in meeting virtually is in the way we vote. When we meet online we will be using the chat function on Zoom to vote. This will require one nominated person in each group to message the administrator with the votes of every member in the room.

For example, if there are five Synod members in the room voting yes, one voting no and one abstaining, the nominated person will check how each person is voting, then type "five votes yes,

one vote no, one abstention". It is not necessary to differentiate between lay or clergy in the chat, unless a count by house Is called for.

It may take some time to collate votes and ensure a majority is reached. During this time please hold off sending through any other queries for the administrator.

Motion 2. Diocesan Council Report

The primary function of the Diocesan Council is to work with the Bishops at a governance level to further the mission and ministry of the Diocese. The Council:

- Is led by our Bishops, working in partnership to advance the vision, mission and values of the Diocese
- Applies a lens of being family, disciples and serving the last, lost and least in their decisionmaking. The mixture of clergy and laity, and urban and rural brings different perspectives that help to grow the Kingdom of God within our Movement
- Provides oversight across key Diocesan work programmes Ben Pringle reports on Diocesan operational matters, Archdeacon Gendy Thomson on mission and ministry, Sisi Fountain on property and insurance, Nick Young on property development
- Makes recommendations to Diocesan Synod that it thinks desirable to best advance the mission of the Diocese
- Dovetails with the Diocesan Board of Trustees in Council meetings we look primarily at the
 missional value of the decisions and proposals that come our way, and the Board of Trustees
 considers the financial implications. It is imperative that we work closely together with the
 Board to ensure balanced decisions are made

Diocesan Council members serve on both the Diocesan Council and the Diocesan Trusts Board, and formal meetings of these bodies are held concurrently. The Council is the Standing Committee of the Diocesan Synod. As such, its membership reflects the Synod model. The Council currently consists of:

- Both Bishops
- Three clergy persons
- Four lay persons

Ben Pringle attends as a non-voting member, along with Harry Gibbons as Governance Secretary (volunteering his time to record minutes), to ensure the Council's work flows into the rest of the mission and ministry in the Diocese. In December last year, the Council thanked Nick Young for his four years of service as Diocesan Manager, allowing him to focus on his newly established position heading up the Diocese's Property Development Programme. Matt Crawshaw has continued in his role as Deputy Diocesan Manager, providing leadership across a number of workstreams including community development, human resourcing and trust management. Sisi Fountain recently replaced Rob Moonlight as the Diocesan Property Manager.

Relational context

The Council meets on average once a month. Prior to the impact of COVID-19, Council meetings would start with prayer and Eucharist at the Cathedral Lady Chapel, with members taking turns to preach a homily. Meetings then moved to the Boardroom at the Anglican Centre. This rhythm was altered during the lockdown, which forced the Council to conduct its meetings via Zoom. Some things have remained unaltered, however. We still commence each meeting with prayer and share with each other our walk with God, seeking to fuse governance and discipleship together. Members have found meeting via videoconference to be an effective way of doing business but have noted the relational challenges that can arise as we spend more time apart. In an effort to capitalise on the benefits of both mediums, the Council will be trialing a model of meeting physically at least three times a year going forward.

Each year there is a retreat for a few days for members of Diocesan Council, the Board of Trustees and Archdeacons. This year we gathered in the parish of Waikanae to worship and discern what God was saying to us as diocesan leaders. It is at these times that relationships are deepened, with prayer and worship the core business. This flows into the year and has been absolutely critical in this most unusual of years!

In the last year

There are regular events in our life together as family that the Council seeks to support through its lens of advancing the mission and ministry of the diocese. These are as varied as supporting diocesan-wide events such as Training Days, Diocesan Synod and family camps, to supporting our Bishops' as they led the diocese tirelessly through lockdown. Highlights from the year have included:

- Supporting our Bishops to implement a new Archdeaconry structure for the diocese, building on the existing focus on governance and local leadership to focus on missional priorities such as church growth, health and planting, intergenerational ministry and discipleship, post-ordination training and the Spiral Network (for pioneering missional enterprises)
- Welcoming new members to the Diocesan Council Sue Chalmers, Rev. Ben Johnson-Frow and Rev. Caro Willis – and releasing existing members back into their local ministries – Rev. Jennie Sims, Rev. Stuart Goodin and Rev. Pete Watson
- Responding to the highly dynamic and disruptive COVID-19 pandemic, helping our Bishops make decisions about how our diocese should respond in the midst of unprecedented events (more on this below)
- Gathering together as family at diocesan events, including Synod in Ohakune in September 2019
- Approving various Board appointments to diocesan governance committees and other related entities such as Wellington City Mission
- Approving and supporting new ventures that have been birthed in the Diocese such as the Ruapehu parish hall being transformed into a lodge retreat space, and new mission ventures such as the Brooklyn Mission Hub
- We have provided support to parishes in seasons of transition, lying fallow or experiencing major change – the impetus of this work has been to share the journey when the road ahead is uncertain by offering resources, both practical and financial, as well as prayer to help mission units journey forward well as part of the Diocesan family where possible and not alone

COVID-19

I must take this opportunity to again recognise the faithfulness, creativity and courage lived out by so many in our Movement during the incredibly challenging months. The way so many of you responded at short notice to the call to worship at home with friends and family, and shortly thereafter to form small groups for discipleship and prayer, was inspiring and encouraging. We have emerged from the lockdown with a stronger sense of togetherness, and a clearer sense of Christ's call for us to be salt and light to the last, lost and least in our local contexts. I was also filled with encouragement at the Diocese's response to our global COVID-19 appeal, which to date has raised over \$74,000 for the Anglican Missions Board, to support four Anglican partnerships (in Fiji, India, Gaza and Mozambique).

Lastly, an experience from the lockdown has been that a number of people have emerged as key leaders in their local faith communities. In order to maximise this opportunity, I have launched a new leadership development curriculum – specifically for an Anglican context – which more than forty people are now taking part in on a weekly basis.

Finance and budgeting

Diocesan Council oversees the management of the General Diocesan Fund with the advice of Finance Committee. Accordingly, Diocesan Council provides guidance to the deliberations of the Finance Committee, and the Diocesan and Finance Managers.

Our focus has very much been on ensuring the financial load on parishes and mission units, and the call on funds from other sources, is as least onerous as possible, and is based on a long-term stewardship perspective. We acknowledge all the hard work of Ben and his team as many parishes are now set up to use Xero and are finding managing their finances easier. This is a simple way that we see church structures being lightweight and low maintenance at the grassroots of mission unit life.

Property

The Diocesan Council shares decision-making around property matters with the Diocesan Board of Trustees. Our focus is very much on the missional intention behind property proposals – that of kaitiakitanga and ensuring that we are advancing our Diocesan vision and mission through our stewardship of, and decision making around, property decisions.

Nick Young has been leading the Diocese's Property Development Programme since late 2019, and is currently working with a number of parishes who wish to work in partnership to develop their existing land and/or buildings to support missional expressions (such as social housing).

We have also supported initiatives to strengthen and repair parish churches, and improve parish facilities, all with the aim of supporting our mission and ministry outreach, our discipleship, and our ability to demonstrate care for our local communities.

Health and Safety

The Diocesan Office has made significant progress this year to improve the diocese's compliance with the Health and Safety at Work Act through the adoption of an electronic health and safety platform – Risk Manager from IMPAC Ltd. The Diocese's Safety Officer, Andrew Black, will be working directly with parishes to provide training over the coming months as we begin bringing Risk Manager online towards the end of 2020. We are confident that this new platform will improve the uptake of reporting and risk mitigation, support training in best-practice behaviour (including at events and when working with vulnerable groups),

and help ensure that all members of our family are always safe and looked after – in any diocesan context.

Our bicultural journey

The Diocesan Council is conscious of the bicultural journey that our Diocese – and indeed the wider Anglican Church – has been on over the years. It is a journey we have continued on this year, and one highlight has been welcoming in and working alongside Pīhopa Waitohiariki Quayle, who commenced as Pīhopa of Te Ūpoko o Te Ika in 2019. The Bishops have valued the mana and humility that Pīhopa Wai brings into her work and look forward to working with her and her team in the year ahead.

The year ahead

With all that 2020 has brought to the church and the world she serves, we as a diocese are called to risk more, to step out in boldness to proclaim the name of Jesus. Each mission unit from across our Diocese continues to be a faithful presence in their local communities. Diocesan Council looks forward to continuing the work that supports best practice of mission and ministry, and to be a group who support our Bishops by seeing our Diocese flourish.



Motion 3. Goodwin Trust Deed Amendment

THAT this Synod:

Notes that the Charitable Scheme for the variation of the following Trust has been prepared
in accordance with the provisions of the Anglican Church Trusts Act 1981, approved by the
Diocesan Board of Trustees, notified to the Attorney-General (who has not objected) and
reported as acceptable by the Chancellor:

The Goodwin Trust

2. Approves the Charitable Scheme.

Explanatory Note

A copy of the Charitable Scheme can be found on the Charities Services website.

The Attorney-General has been notified in accordance with section 15(1) of the Act, and as at the date of this motion (3 August 2020) has not yet notified any objection. The Chancellor is yet to report that the Scheme is acceptable and in order for approval by Synod (section 14 of the Act). These matters will be resolved before Synod, but there have been timing issues because of the COVID-19 Lockdown.

The Goodwin Trust is constituted by a Declaration of Trust made between the late Geoffrey Denzil Mallaby Goodwin (as Settlor) and the Wellington Diocesan Board of Trustees (as Trustee) dated 4 May 1973 ("the Trust Deed"). The original gift was of shares in Fletcher Holdings Limited. There is an Advisory Trustee, Jeremy Goodwin, an Auckland solicitor who is the grandson of the Settlor.

Under Clause 1 of the Trust Deed, one half of the annual income is required to be paid to the Vicar and Churchwardens of Saint John's Church, Trentham, to be applied for the benefit of the Choir in such manner as advised by the Advisory Trustee, with a desire that half the income be used to purchase Christmas presents for the Choir and Organist. The other half is required to be accumulated.

There has not been a choir at Saint John's Church for many years.

The scheme proposes to change the charitable purposes (so that they are for "ecclesiastical purposes relating to Saint John's Church, Trentham" which reflects language used in Clause 5 of the Trust Deed) and to remove the compulsory accumulation. In addition, the investment power of the trustee is to be amended so as to remove the historic references to Fletcher Holdings Limited shares and to the Wellington Stock Exchange.

 - inserting a new clause 1 as follows
 - "1 The Bishop must determine the locations in the diocese which will serve best for holding a Regional Meeting (the Meeting), as set out in this Canon."

and renumbering the remaining clauses of Schedule 2 accordingly.

ii. replacing in clause 2 (clause 1 in unamended Schedule) the words

", from each archdeaconry, to gather as a Regional Meeting (the Meeting),

with two archdeaconries combined for the Meeting where practicable,".

with the words

"from each region of the Diocese to gather as a Regional Meeting,"

iii. replacing in clause 4 (clause 3 in unamended Schedule) the words

"regional Archdeacons concerned"

with the words

"an archdeacon or other person from the region concerned appointed by the Bishop to chair the Meeting for that region ('the Meeting Chair')"

iv. replacing in clause 4 the word

"archdeaconry"

with the word

"region".

v. replacing in clause 5 (clause 4 of unamended Schedule) the words

"the regional Archdeacons concerned"

with the words

"each Meeting Chair".

vi. deleting from clause 5 the words

", with the chair of a combined Meeting being determined by the Bishop".

vii. deleting clause 6 (clause 5 of unamended Schedule).

viii.

- 8. Clause 2(d) of Standing Resolution A5 is hereby as follows:
 - i. replacing the word

"archdeaconries"

with the word

"clusters".

replacing the words

"The Clerical Association of each archdeaconry"

with the words

"each region in the diocese".

- 9. Standing Resolution D7 Archdeacons' Expenses is hereby deleted and
 - i. the remaining Standing Resolutions renumbered accordingly.
 - ii. Section D of the Contents Table of Diocesan Standing Resolutions is consequentially amended by
 - (a) deleting reference to Standing Resolution D7
 - (b) renumbering the remaining sections of Section D accordingly.
- 10. Clause (4)(a)(iii) of Standing Resolution E10 is amended by
 - i. replacing the words

"the Regional Archdeacon who must consult with the Diocesan Property Manager on any property matters" with the words "the Diocesan Property Manager".

Explanatory Note

The Bishops decided that the leadership structure of the Diocese would be improved if each archdeacon was responsible for a key portfolio rather than most archdeacons being responsible for a geographic area in the Diocese, with the Bishops delegating regional leadership tasks as they saw fit. Under this leadership structure most of the work formerly carried out by local geographically based archdeacons is no longer needed.

The rationale for this change is that Clusters are now well established and have proven effective in providing clergy with the pastoral and missional support which once was an important part of the role of a geographical archdeacon.

The primary remaining part of the role of the geographic archdeacon was administrative and is, for the most part, able to be delegated to the Diocesan Property Manager. A few aspects of this role may be delegated by the Bishop to someone such as an archdeacon from the region of the diocese concerned.

The Bishops have decided that this change will advance the mission of the Diocese by reducing time and energy put into administration and releasing that energy for mission and ministry. Diocesan Council sees this decision as being in line with its low-weight light-maintenance policy, and supports this change.

Diocesan Council therefore commends to the Diocese this Canon which makes the amendments necessary to remove from a number of diocesan Canons and Standing Resolutions of Synod provisions in which geographic archdeacons are required to carry out certain roles, with a consequential change that regions replace archdeaconries for certain diocesan administrative purposes.

In some cases, the amendment would remove an administrative task currently exercised by a geographic archdeacon and not reassign that task to another person. Eg., 2(i) above would remove the requirement that the local Archdeacon be consulted whenever there is a proposal to alter the boundaries of any Parish. Section 10 of the Mission Units Canon does not limit who may make submissions on such a matter but does require that Diocesan Council consider all submissions before making any alteration. The Council thinks that this and similar changes remove an administrative task at little cost to our administrative efficiency.

In other cases, the amendment would remove an administrative task currently exercised by a geographic archdeacon and reassign that task to some other person specifically chosen for that task. There are two major instances of this.

The first such instance is where geographic archdeacons currently have certain tasks to do with parish properties. The amendment would remove such tasks from the geographic archdeacons and reassign them to the diocesan Property Manager who, in practice, has been the major player in such

decisions for many years now. In the case of disagreement between the Mission Unit and the Property Manager, the provision for an appeal to the Bishop for a ruling is retained.

The second such instance is where geographic archdeacons currently have certain tasks relating to the Regional Meetings. The amendment would remove most such tasks from the geographic archdeacons and reassign them to a regional Meeting Chair. The Meeting Chair would be an archdeacon or other person from the region concerned appointed by the Bishop. One task would be deleted, that of keeping a list of "best practice." Best practice is thought to be something for the Bishops to determine.

- 2. THAT clause (2)(a) of Standing Resolution E10 Clergy Housing Policy is amended by
 - (i) replacing the words

"owned by the Mission Unit"

with the words

"the Title of which is held by the Diocesan Trust Board".

Explanatory Note

This amendment rectifies an oversight in the Canon to amend the Diocesan Mission Units Canon 2016 which was passed at Synod 2017.

In that Canon

- (i) section 2(a) replaced the heading (in the unamended Mission Units Canon)"Ownership of Church Property"with the heading"The Use of Church Property".
- (ii) (ii) section 2(b) replaced words (in the unamended Mission Units Canon) which read "If a church, church hall, or vicarage is not owned by the Wellington Diocesan Board of Trustees, the vestry must, from time to time, consider whether to transfer the title of the property to the Wellington Diocesan Board of Trustees." with the following words "If the title of a church, church hall, or vicarage is not held by the Wellington Diocesan Board of Trustees, the vestry must, from time to time, consider whether to transfer that title to the Wellington Diocesan Board of Trustees."

The Explanation for this change to Synod 2017 was that these amendments of the Mission Units Canon eliminated the expression "ownership/owned" and replaced it with a more careful concept of holding "title." The basis for this proposed change was that all church property is held in trust, and the use of the term "ownership" can be misleading to those unfamiliar with a proper nuance to that expression when used of church property.

Motion 7. Diocesan Council empowered to make adjustments to the Diocesan Canons and/or Standing Orders of Synod where necessary

THAT this Synod:

Empower Diocesan Council to make adjustments, where necessary, to the Diocesan Canons and/or Standing Orders of Synod for the purposes of enabling Diocesan Synod to function effectively when it convenes. Any adjustments would be listed in the Omnibus provision at a future Synod.

Explanatory Note

Due to the extraordinary circumstances surrounding Diocesan Synod this year, there is an opportunity for Diocesan Council to conduct a review after the event to consider the effectiveness of this year's approach. Given there remains a risk that future Diocesan Synods could be affected by a major event such as a pandemic, it is prudent to use this year's event to test our Diocese's ability to conduct the business of Synod despite not being able to gather physically together.

The review would consider the degree to which the Diocese's current Canons and Standing Orders of Synod enabling or inhibit Synod from functioning as effectively as possible – and whether any changes to the Diocesan Canons and/or Standing Orders of Synod should be made in time for Synod 2021.

It is important to stress that this motion would not give Diocesan Council broader powers to make changes to the Canons – as this function rests solely with Synod. Rather, Council would receive narrow powers to make changes to the Canons (and/or Standing Orders of Synod) that directly apply to the operation of Diocesan Synod. Further, any adjustments would be listed in the Omnibus provision at a future Synod.
